



Privacy Policy

Mini Whinny Therapy Horses (“we,” “us,” or “our”) respects your privacy. This policy explains what information we collect through our website at miniwhinny.org, how we use it, and the choices you have.

Information we collect

- **Browsing our site.** You can visit our website without giving us any personal information. We do not require you to create an account.
- **Information you share with us.** If you contact us by email or phone — for example, to ask a question or schedule a visit — we receive whatever you choose to provide, such as your name, your organization, your phone number, your email address, and the contents of your message.
- **Donations.** Donations are processed by our payment provider, Stripe. We do not collect or store your full payment card details — Stripe handles that directly and securely. Through Stripe we may receive limited information such as your name, email address, and the amount and date of your gift, so we can thank you and keep accurate records.
- **Automatically collected information.** Like most websites, our hosting provider may automatically log basic technical information (such as your IP address, browser type, and the pages you visit) to keep the site running and secure. We do not use this information to identify you personally.
- **Cookies.** Our website itself does not use advertising or tracking cookies. Some third-party tools we link to (such as Stripe’s donation page) may use cookies that are necessary for their own services to work.

How we use information

- To respond to your messages and arrange visits.
- To process and acknowledge donations and keep accurate financial records.
- To operate, maintain, and protect our website.
- To meet our legal and tax obligations as a non-profit.

How we share information

We do not sell or rent your personal information. We share information only:

- with trusted service providers who help us operate — for example, Stripe for donation processing and Vercel for website hosting;
- when required by law, or to protect the rights, property, or safety of our organization or others; and
- with your consent.

How long we keep information

We keep the information you give us for as long as needed to respond to you, maintain our records, and meet legal and tax requirements, after which we securely dispose of it.

Children's privacy

Our website is intended for a general audience and is not directed to children under 13. We do not knowingly collect personal information from children. If you believe a child has provided us information, please contact us and we will delete it.

Your choices

You may contact us at any time to ask what information we have about you, to correct it, or to ask us to delete information you have shared with us. We will do our best to honor reasonable requests.

Our site may link to other websites, such as our donation page. We are not responsible for the privacy practices of those sites, and we encourage you to read their policies.

Security

We take reasonable steps to protect the information we hold. However, no method of transmission over the internet or electronic storage is completely secure, and we cannot guarantee absolute security.
